



AGREEMENT

ON

ACADEMIC EXCHANGE

BETWEEN

IVANE JAVAKHISHVILI TBILISI STATE UNIVERSITY

AND

FACULTY OF ARCHITECTURE, UNIVERSIDADE DE LISBOA

Rector of LEPL - Ivane Javakhishvili Tbilisi State University (Georgia) professor Vladimer Papava, and the President of the Faculty of Architecture of Universidade de Lisboa (Portugal) professor João Pardal Monteiro, with the objective of promoting cooperation in the fields of education and academic research, agree to conclude the following agreement on academic exchange:

Article 1

Both parties agree to promote the following activities so as to enhance their educational and academic research in the necessary fields:

- (1) Activities such as collaborative research, joint projects, lectures, symposia etc., and the exchange of researchers pertaining thereto;
- (2) Exchange of information and materials in those fields, which are of interest to both parties;
- (3) Exchange of undergraduate and graduate students as well as faculty members

Article 2

Specific matters pertaining to the implementation of the exchanges based on this agreement shall be negotiated and agreed upon between the both parties concerned in each specific case and may be stipulated in writing as memorandums complementary to this agreement.

Both parties will designate a representative, who will work for implementing activities and programs envisaged by the given document. Mrs. Tea Gergedava (email: tea.gergedava@tsu.ge; +995.32.2221103), Head of the Department of Foreign Relations will serve as the representative of TSU in this agreement and Prof. João Pardal Monteirowill be the designated representative of the Faculty of Architecture of Universidade de Lisboa.





Article 3

This agreement shall become effective on the date of its signing by the representatives of both parties and shall be in force for 5 (five) years.

Article 4

This agreement is subject to revisions by mutual written consent. Any disputes arisen during the implementation of any negotiated activities will be settled with the help of consultation and negotiation between the two sides.

Article 5

Either party may, by giving 6 (six) months' written notice to the other party, terminate the agreement. However, the termination of this agreement shall not affect the implementation of the collaborative activities established under it prior to such termination.

Article 6

In the absence of any such early termination, the renewal of this agreement shall be discussed by the two parties no less than 6 (six) months prior to the natural termination of the current agreement.

Article 7

This agreement shall bind neither TSU nor the Faculty of Architecture of Universidade de Lisboa to any financial commitment unless there is a mutually signed agreement between the sides.

The memorandum of understanding is drawn in two originals in English language in Lisbon on the 16th of February, 2015 and each party shall retain a copy. Both originals are identical and have equal legal value.
